Notably, she was the first Chinese research analyst and writer to join The Economist Intelligence Unit (EIU), where she later became the Director of the Global Economics Unit, and led the Access China project, expanding it into a global team of analysts providing analysis of Chinese outbound investment. She was also been involved in The Economist Group's various China projects, including on CQ Roll Call and Global Business Review.

She also served as the Chairwoman for internal review at EIU with the European Securities and Markets Authority.

Liu is a sought-after speaker and moderator at international conferences and forums, where she shares her expertise on China's economy, labour markets, trade and investment policy framework, trade relations, supply chain trends, the Belt & Road Initiative and its key industry sector development in China. She takes particular interest in China's economic and geopolitical relationship with the rest of the world.

Dr. Liu has contributed to contributed to major financial publications and academic journals, including Oxford Economic Papers, Project Syndicate, The Economist World in, and is frequently interviewed by the BBC, CNBC, CNN, CBS, HBO, NPR and CCTV.

She has also been a guest lecturer at New York University, Tsinghua University, the Chinese Academy of Social Sciences and Fudan University.

Qian Liu was named Young Global Leader by the World Economic Forum, a community with brightest global minds under the age of 40 to improve the state of the world.

Qian is also a prominent advocate for gender equality, and introduces cutting edge global economic research on gender, and promotes intelligent public debates reaching millions of people. She has served as Vice Chair for the British Chamber of Commerce in China. Also, she has been recognized with the Outstanding Women Award in China by Caixin, which honours women who have made significant contributions to their fields.

She is also the author of *Gender Economics*, published by CITIC Press Group, in which she attempts to use classic Economics studies to advocate for gender equality, with rational recommendations to women, covering a range of topics such as education, career, marriage, fertility etc.

Dr. Liu earned her PhD in economics from Uppsala University, Sweden, and was previously a visiting scholar at UC Berkeley, and received business executive leadership training from Stanford University and attended Global Leadership and Public Policy program at Harvard University.
