- Dr Fan is one of China's most influential, leading economists, based in Beijing and sat for two term on the powerful Monetary Policy Committee of The People's Bank of China until April 2010.
- He also heads the National Economic Research Institute (NERI) and Chairman of the China Reform Foundation, China's first economic think-tank, he is one of China's leading reform advocates.
- Ranked number 33 in *Foreign Policy's* 2008 list of the top 100 public intellectuals.
